Item 1 Consider recommending the acceptance of the Homekey+ Program award in the amount of \$18,689,375, the Stanislaus County Community Services Agency (CSA) award in the amount of \$922,837 in Homeless Housing Assistance and Prevention (HHAP), the Behavioral Health and Recovery Services (BHRS) award in the amount of \$500,000 and recommend the approval of agreements to the project; Additionally, approval of a City of Modesto Community Development Block Grant (CDBG) loan in an amount not to exceed \$3,007,163; and an allocation of \$350,000 for staff activity to El Capitan Homekey LP for the project located at 1121 Needham Street.
