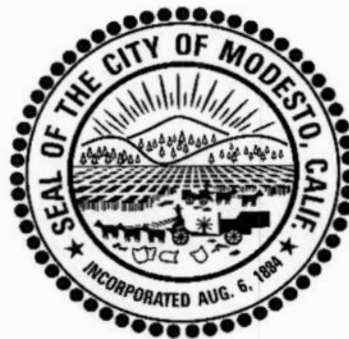

PLEASE TAKE NOTICE that on Thursday, February 27, 2025, the Board of Building Appeals of the City of Modesto conducted a public hearing regarding the real property situated in the City of Modesto commonly referred to as 4017 TIERRA LAGO DR (hereinafter referred to collectively as the "premises"). Following the public hearing, the Board adopted Resolution No. 2025-04, a true and correct copy of which is attached to this Notice.

PLEASE TAKE FURTHER NOTICE THAT PURSUANT TO RESOLUTION 2025-04, THE BOARD APPROVED A MOTION TO DECLARE THE PROPERTY A PUBLIC NUISANCE AND UPHOLD THE NOTICE AND ORDER DATED June 12, 2024 . THE BOARD APPROVED THE CITY'S RECOMMENDATION AS FOLLOWS:

THE BOARD DEEMS THE PROPERTY UNSAFE AND A PUBLIC NUISANCE AND ORDERS THE CITY TO RECORD A CERTIFICATE OF EXISTENCE OF THE UNSAFE BUILDING; THE BOARD AFFIRMS ADMINISTRATIVE COSTS IN THE AMOUNT OF FIVE HUNDRED AND FIFTY-ONE DOLLARS AND FIFTEEN CENTS (\$551.15); THE BOARD AFFIRMS THE CIVIL PENALTIES IN THE AMOUNT OF ONE THOUSAND THREE HUNDRED DOLLARS (\$1,300.00); THE BOARD FURTHER ORDERS CIVIL PENALTIES CONTINUE TO ACCRUE IN THE AMOUNT OF ONE HUNDRED DOLLARS (\$100.00) PER DAY FROM CIVIL PENALTY HEARING UPDATE DATE, FEBRUARY 27, 2025.

THE FULL CIVIL PENALTIES AND ADMINISTRATIVE HEARING COST ARE DUE AND MADE A

LIEN AND SPECIAL ASSESSMENT AGAINST THE REAL PROPERTY ADDRESSED AS 4017 TIERRA LAGO DRIVE, MODESTO CA 95356, PARCEL NUMBER 078053014.

PLEASE TAKE FURTHER NOTICE that the owners of the premises or any other interested person having any objections, or feeling aggrieved at any proceeding taken by the City of Modesto in ordering abatement of the nuisance, must bring an action in a court of competent jurisdiction pursuant to California Code of Civil Procedure sections 1094.5 and 1094.6 within ninety (90) days of the final decision of the Board of Building Appeals, to contest the validity of any proceedings leading up to and including the adoption of the resolution, otherwise all objections will be deemed to have been waived.

RESOLUTION NO. 2025-04

THE BOARD APPROVED A MOTION TO DECLARE THE PROPERTY A PUBLIC NUISANCE AND UPHOLD THE NOTICE AND ORDER DATED June 12, 2024. THE BOARD APPROVED THE CITY'S RECOMMENDATION AS FOLLOWS; THE BOARD DEEMS THE PROPERTY UNSAFE AND A PUBLIC NUISANCE AND ORDERS THE CITY TO RECORD A CERTIFICATE OF EXISTENCE OF THE UNSAFE BUILDING; THE BOARD AFFIRMS ADMINISTRATIVE COSTS IN THE AMOUNT OF FIVE HUNDRED AND FIFTY-ONE DOLLARS AND FIFTEEN CENTS (\$551.15); THE BOARD AFFIRMS THE CIVIL PENALTIES IN THE AMOUNT OF ONE THOUSAND THREE HUNDRED DOLLARS (\$1,300.00); THE BOARD FURTHER ORDERS CIVIL PENALTIES CONTINUE TO ACCRUE IN THE AMOUNT OF ONE HUNDRED DOLLARS (\$100.00) PER DAY FROM CIVIL PENALTY HEARING UPDATE DATE, FEBRUARY 27, 2025. THE FULL CIVIL PENALTIES AND ADMINISTRATIVE HEARING COST ARE DUE AND MADE A LIEN AND SPECIAL ASSESSMENT AGAINST THE REAL PROPERTY ADDRESSED AS 4017 TIERRA LAGO DRIVE, MODESTO CA 95356, PARCEL NUMBER 078053014.

WHEREAS, LE THANH ET AL have/has title to and is/are the recorded owner(s) of property located at 4017 TIERRA LAGO DR in the City of Modesto, County of Stanislaus, hereinafter referred to collectively as the "premises"; and

WHEREAS, the premises at 4017 TIERRA LAGO DR consists of CONSTRUCTION WITHOUT PERMIT ; and

WHEREAS, the Chief Building Official of the City of Modesto is authorized by the Building Maintenance Code of the City of Modesto to enforce all provisions of the Code including authority to inspect any building or structure and order that any such building or structure determined under the Building Maintenance Code to be Unsafe and Unfit for Human Occupancy be declared a public nuisance and order the recorded owner to abate the nuisance conditions by demolition abatement of the unsafe structures and meet deadlines set for construction on the property; and

WHEREAS, inspection of the premises was conducted by City of Modesto Building Safety Division personnel on Feb 22, 2024 ; and

WHEREAS, a Notice and Order dated June 12, 2024, was issued by the Chief Building Official and ordered;
TESTING UPDATED ORDERS; and

WHEREAS, said Notice and Order dated June 12, 2024, gave notice that the premises were found to be deemed unsafe and a public nuisance; and

WHEREAS, on June 12, 2024, said Notice and Order of June 12, 2024,, was mailed by certified mail, postage prepaid, return receipt requested to record owners and the holder of the deed of trust of record, pursuant to Article 12 of the Building Maintenance Code of the City of Modesto; and

WHEREAS, on June 12, 2024, said Notice and Order of June 12, 2024, was posted on the premises;
and

WHEREAS, the owner(s) of said premises have failed to complete work within the time specified in said Notice and Order and, therefore, the owner(s) are now in violation of the Building Maintenance Code of the City of Modesto; and

WHEREAS, the property continues to constitute a public nuisance; and

WHEREAS, pursuant to California Code of Regulations, Title 25, Division 1, Chapter 1, Subchapter 1, Article 6, Section 66, thirty (30) days after the posting of copies of this resolution, the City of Modesto shall be deemed to have acquired jurisdiction to abate such nuisance by razing or removing the building unless the nuisance is abated by the owner or the person interested within the thirty (30) day period or any extension thereof granted by the Board of Building Appeals as provided in Article 12 of the Building Maintenance Code. In the event that the nuisance is not abated within the time prescribed, the City of Modesto may thereupon raze and remove the premises or have the same done under its direction and supervision; and

WHEREAS, on Aug 12, 2024 , a “Notice of Board of Building Appeals Civil Penalty Hearing” was mailed by certified mail, postage prepaid, return receipt requested, to record owner(s) and posted on the property, pursuant to California Code of Regulations, Title 25, Division 1, Chapter 1, Subchapter 1, Article 6, Sections 58 and 60; and

WHEREAS, said “Notice of Board of Building Appeals Civil Penalty Hearing (update)” gave notice that a public hearing would be held by the Board of Building Appeals of the City of Modesto, on Thursday, February 27, 2025 at 4:00 p.m., in the basement level Conference Room B300 – Tenth Street Place, 1010 Tenth Street, Modesto, California; regarding the real property situated in the City of Modesto commonly referred to as 4017 TIERRA LAGO DR; and

WHEREAS, a duly noticed public hearing of the Board was held at date, time, and place as mentioned above, for the purpose to hear and receive evidence to determine whether said premises constitutes a public nuisance and to consider other appropriate action to abate such nuisance.

NOW, THEREFORE, BE IT RESOLVED by the Board of Building Appeals of the City of Modesto, that the following be ordered:

THE BOARD UPHOLDS THE NOTICE AND ORDER DATED June 12, 2024, THE BOARD DEEMS THE PROPERTY UNSAFE AND A PUBLIC NUISANCE AND ORDERS THE CITY TO RECORD A CERTIFICATE OF EXISTENCE OF THE UNSAFE BUILDING; THE BOARD AFFIRMS ADMINISTRATIVE COSTS IN THE AMOUNT OF FIVE HUNDRED AND FIFTY-ONE DOLLARS AND FIFTEEN CENTS (\$551.15); THE BOARD AFFIRMS THE CIVIL PENALTIES IN THE AMOUNT OF ONE THOUSAND THREE HUNDRED DOLLARS (\$1,300.00); THE BOARD FURTHER ORDERS CIVIL PENALTIES CONTINUE TO ACCRUE IN THE AMOUNT OF ONE HUNDRED DOLLARS (\$100.00) PER DAY FROM CIVIL PENALTY HEARING UPDATE DATE, FEBRUARY 27, 2025.

THE FULL CIVIL PENALTIES AND ADMINISTRATIVE HEARING COST ARE DUE AND MADE A LIEN AND SPECIAL ASSESSMENT AGAINST THE REAL PROPERTY ADDRESSED AS 4017 TIERRA LAGO DRIVE, MODESTO CA 95356, PARCEL NUMBER 078053014.

BE IT FURTHER RESOLVED:

1. If the final inspection approval is not completed by October 21, 2024, the City of Modesto shall be

deemed to have acquired jurisdiction to abate such nuisance by razing or removing the buildings, unless the nuisance is abated by the owner or other person, or any extension thereof granted by the Board of Building Appeals. In the event that the nuisance is not abated within the time prescribed, the City of Modesto may thereupon raze and remove the building so declared to constitute a nuisance or have the same done under its direction and supervision.

2. In the event that the City of Modesto razes and removes the buildings so declared to constitute a nuisance or have the same done under its direction and supervision, the City of Modesto shall keep an itemized account of the expense involved in the razing or removing of any such buildings and shall deduct therefrom the amount received from the sale of any building materials pursuant to California Code of Regulations, Title 25, Division 1, Chapter 1, Subchapter 1, Article 6, Section 68. The City of Modesto may proceed to recover its expenses in the razing or removing of any such buildings pursuant to California Code of Regulations, Title 25, Division 1, Chapter 1, Subchapter 1, Article 6, Section 68 and Section 70.


BE IT FURTHER RESOLVED that the City of Modesto shall cause to be posted on the premises a Notice of the Passage of this Resolution No. 2025-04 , declaring a nuisance and directing abatement of the nuisance.

BE IT FURTHER RESOLVED that within thirty (30) days after passage of this Resolution No. 2025-04, the City of Modesto shall cause to be posted a copy of said resolution conspicuously on the buildings so declared to be a nuisance and mail another copy of the resolution by certified mail, postage prepaid, return receipt requested, to (1) the person(s) owning the land on which the buildings are located as such person's name and address appear on the last equalized assessment roll, and (2) to each mortgagee or beneficiary under any deed of trust, of record, at the last known address of such mortgagee or beneficiary. The officer or employee giving notice as aforesaid, shall file an affidavit thereof in the manner provided for in California Code of Regulations, Title 25, Division 1, Chapter 1, Subchapter 1, Article 6, Section 58.

The foregoing matter was introduced at the regular meeting of the Board of Building Appeals of the City of Modesto held on February 27, 2025 , by Board Member, Huelon Usrey who moved its adoption, which motion being duly seconded by Board Chair, John Bergman, was upon roll call carried in the resolution adopted by the following vote:


